

## TITLE TO REAL ESTATE

Haywoodin the State aforesaid, the right whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said these certain 14 parcels P. Haywood,

Township, Greenville County, State of South Carolina,  
near Piney Mountain on Clewmont Drive, being a portion of lands known as Piney Mountain,  
Park and being described by metes and bounds on plat made by Brodie and Bedell, Engineers,  
August 30th, 1913, being known and designated as Lots Nos. 120, 121, 122, 123, 124, 125,  
126, 127, 128, 129, 130, 131, 132, and 133, according to said plat.

Also all that certain piece, parcel or strip of land situated, lying and being  
in the State and County aforesaid, between C. S. and A. Railway and Southern Railway,  
beginning at a point in a straight line of Lot 118, and running in a westerly direction  
to the Stone Line; this boundary is intended to cover all the land between said Railways."
