## TITLE TO REAL ESTATE

in consideration of the sum of one paid by Lula R. McBee

in the State aforesaid, the persons whereof are herein acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and  
convey unto the said Lula R. McBee Township, Greenville County, State of South Carolina,  
all that place, parcel or lot of land in Greenville,  
in the Second Ward of the City of Greenville, known and designated as Lot No. 27 on the  
plat of Rowley property recorded in the office of the R. N. C. for said County and State  
in Plat Book "C", at page 5, and having according to said plat, the following metes and  
bounds, to-wit: Beginning at a stake on the east side of Lavinia Avenue 55 feet South-  
ward from the South side of East Avenue (said stake being on the Southwest corner of lot  
No. 28 as shown on said plat, and running thence along Lavinia Avenue S. 21-45 E. 55 feet  
to a stake on the Northwest corner of lot No. 28; thence with line of last mentioned lot,  
N. 76-30 E. 155 feet to a stake on an alley; thence along said alley N. 21-45 W. 55 feet  
to a stake on the Southeast corner of lot No. 28; thence with line of last mentioned lot,  
S. 76-30 E. 155 feet, to the beginning corner.
