Greene all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina,

being lot no 2 of Bruce & White Land, Plat Book E. page 58.

Beginning at a stake on an unnamed street, point corner lots nos 3 and 2 and running with said unnamed street S 9.00 E. 39 feet and thence to a stake corner of lot No 1, thence with line of lot no 1 N. 67.5 feet E. 11.45 feet to a stake in line of lot #10, thence with line of lot #10 N. 9.5 W. 32 feet to a stake corner of lot #8; thence with line of lot #8 S. 73.5 W. 14.3 feet to the beginning corner.
