

LEASE

THE STATE OF SOUTH CAROLINA,
County of Greenville.

Mrs J. F. Stuart

in consideration of the rental hereinbefore mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto,

J. H. Brathwaite

lessor,

for the following use, viz: *One meat break house for residence, on*
Broadway Avenue, Greenville, S.C.

lessee,

for the term of *one year from September 1, 1934*

and the said lessee

in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of *Thirty-five (\$35.00)*

Dollars.

per *month* payable *quarterly*

The lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from leaks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be erected that may connect with the gable or any other outside part of the building must be consented to by the lessor before being erected.

To have and to hold the said premises unto the said lessee *J. H. Brathwaite*, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party *one month's* written notice to do so at the time of the annual renewal, but one month's notice of the premises by fire or making it unfit for occupancy or other casualty, or one month's notice of rent, shall terminate this lease, at the option of either. The lessee agree to make good all breakage of glass and all other property damage to the premises during the term, except such as are produced by natural decay and agrees to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor submit without the lessors written consent.

The lessee hereby acknowledges having a duplicate of this lease.
