 in consideration of the sum hereinunder mentioned, have granted, bargained and released by these presents do grant, bargain, and lease unto,

Dr. A. J. Dernid lessee,

the Room located over Wilfred Cafeteria the

for the term of from May 15th 1936 until May 31, 1938 with the
 privilege of renewing at the same rental provided the
Wilfred Cafeteria remains at same Rental and the said lessee
 in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Thirty-five dollars

per month Dollars

per month payable in advance.

The lessor hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lease to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages therefor should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Quaint signs to be erected that may conflict with the paint or any other outside part of the building must be consented to by the lessor before being painted.

The lessor gives to the lessee the privilege of
 removing at termination of lease all improvements
 and fixtures installed at beginning of lease.

To have and to hold the said premises unto the said lessee, Dr. A. J. Dernid, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party one months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or one months arrear of rent, shall terminate this lease, if the lessor so desires. The lessee agree to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor ~~unless done without the lessor's written consent~~.
