

## LEASE

THE STATE OF SOUTH CAROLINA,

lessor,

in consideration of the rental hereinafter mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto

Robert W. Altom

lessee,

for the following use, viz.: meat market and grocery

the

for the term of one year beginning January 1st - 1938 to  
January 1st 1939

and the said lessee

in consideration of the use of said premises for the said term, promising to pay the said lessor the sum of Seventy Five (75<sup>00</sup>)

Dollars

per month

payable

The lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessor only requires of the lessee the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from leaks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the term then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be erected that may conflict with the porch or any other outside part of the building must be consented to by the lessor before being erected.

The Lessor, Mrs. Nell K. Hopkins, agrees to give  
the lessee, Robert W. Altom, first chance to rent  
this building at the expiration of this lease.  
(Jan 1st, 1939)

To have and to hold the said premises unto the said lessee Robert W. Altom executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party two months written notice previous to the time of the desired termination, but the discontinuance of the premises by the or making it unfit for occupancy or other casualty, or months accrued of rent, shall terminate this lease, at the lessor's discretion. The lessee agree to make good all breaking of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-rent without the lessor's written consent.

The lessee hereby acknowledges having a duplicate of this lease.
