

LEASE

THE STATE OF SOUTH CAROLINA
County of Greenville

Benjamin J. Black and Vera Clegg Black lessor, &
in consideration of the rental hereinabove mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto
Greenville Petroleum Company, Inc. lessee,
for the following use, viz., gasoline and oil filling station, soft drink stand, and
grocery store and other similar uses
the following described property to wit all that certain piece of land and tract of
land in Greenville, Greenville County, being the same property
conveyed to the above herein by the lessor by deed dated August 29, 1938
and recorded in the office of the R. M. C. for Greenville County in Deed
Book 205, Page 322 for the term of ten (10) years
and the said lessee
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of One (\$1.00)

in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of One (\$1.00)

Dollars per year payable in advance.

The lessor hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessee to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from such should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Quaint rights to be granted that may connect with the property or any other outside part of the building must be consented to by the lessor before being erected.

The lessor agrees to pay all general and special taxes and assessments that may be levied or assessed against said premises and/or property owned by them located thereon, and the lessee further agrees that all buildings, structures, tanks, pumps, piping, racks, and other equipment placed upon the premises by said lessor or any other person acting under arrangement with the lessor, whether or not connected with the soil or affixed to the realty, shall remain the sole property of the lessor, and at the expiration of this lease by the legal action of law or otherwise, such items shall have and are hereby given the right at any time to remove them (30) days after such termination, to enter upon and remove from such premises any equipment by it at any time placed thereon to clean and to build the said property for the success of the said lessor.

The lessor hereby acknowledges having a duplicate of this lease
Witness our hands and seals the 29th day of August 1938
for the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party one (1) month written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or any other cause shall terminate this lease, if the lessor so desires. The lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor and subject without the lessor's written consent.
