

LEASE

THE STATE OF SOUTH CAROLINA, }
County of Greenville. }

Jerry S. Battin and Henry Coopel lessor,
in consideration of the rental hereinabove mentioned, have granted, bargained and released, and by these presents do grant, bargain, and lease unto

M. G. Clark of Greenville Street, S.C. lessee,
for the following uses, viz.: one building located opposite corner of S.C. & Clark and
Leaving room at the rear of the building generally used the
by J. S. Battin.
for the term of three years, beginning October the 31st, 1938.
To Octobber 31st, 1941.

In consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Fifteen & 00/100

Dollar

22.00/100 payable October the 25th of each month

The lessor hereby agrees to take the building just as it stands without otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessee to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessee not to pay any damages from leaks should any occur. Use of the premises for any business other than herein named for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be erected shall may connect with the parapet or any other outside part of the building, must be consented to by the lessor before being erected.

To have and to hold the said premises unto the said lessee, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms and under the party desiring to renew the same, shall give notice of the same to the other party one month written notice previous to the time of the desired termination, but the destruction of the premises by fire, or rendering it unfit for occupancy or other casualty, or nonpayment of rent, shall terminate this lease, of the lessor so desires. The lessee agrees to make good all breaking of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-rent without the lessor written consent.

The lessee hereby acknowledges having a duplicate of this lease.
