In consideration of the rental hereinbefore mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto

J. H. Tollison

the One Building located at 26 West Coffee
St in the City of Greenville, S.C. nature of
business Barber Shop.

for the term of Five years - Optional

lessor,

lessee,

in consideration of the use of said premises for the said term, promise to pay the said lessor the sum of Thirty Dollars
.30 Dollars

per month payable on the first day of each month.

The lessee hereby agrees to take the building ~~as it stands~~ unless otherwise agreed upon in writing, and the lessor only require of the lessee the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from break should any happen. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the term, then the whole of the unexpired time becomes immediately due and payable.

Outsides signs to be erected that may conflict with the garage or any other outside part of the building must be consented to by the lessor before being erected.

This contract is optional and subject to change at the first of each year of the five years from the date of same by the lessor or the lessee giving the other a thirty days written notice. The optional term of this contract is based on the conditions of times.

To have and to hold the said premises unto the said lessee, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party one months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or months amount of rent, shall terminate this lease, of the lessor to deliver. The lessee agree to make good all damage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations to the premises without the written consent of the lessor.
