

## LEASE

THE STATE OF SOUTH CAROLINA,

In consideration of the rental hereinbefore mentioned, here granted, bargained and released and by these presents do grant, bargain, and lease unto

C. P. Robinson

lessor,

lessee,

the One Store Building and Fourteen Tenant Cabins -  
known as "Shady Grove tourist camp" on New Bruncombe Road on  
Route # 5 - Greenville & C.  
for the term of One year - Jan 1 - 1942 - Through Dec 31 - 1942

and the said lessee

in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of One Hundred Forty

five Dollars

payable on the 20<sup>th</sup> day of each and

every month

the said monthly rent to be paid in advance, unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned herein above. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages for leaks should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Or else signs to be written that make contact with the parapet or any other outside part of the building must be concealed to by the lessor before being removed.

To have and to hold the said premises under the said lease, C. P. Robinson, his  
successors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party one months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or one month's notice of such, shall terminate this lease, if the lessor so desires. The lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and accidents, and agrees to make no repairs, improvements or alterations in the premises without the written consent of the lessor not subject without the lessor's written consent.
