

## LEASE

THE STATE OF SOUTH CAROLINA,  
County of Greenville.

Henderson & Mr. Dowell, Agents for J. H. Pierce  
in consideration of the rental hereinafter mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto  
C. J. Price  
the following, viz.: the building situated in the City of Greenville,  
S. C. and East Washington Street, and being described as near No. 104 on  
E. Washington St.  
for the term of 5 years.

and the said lessee  
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of \$400.00 (forty dollars) per month.

Dated:

For receipt  
monthly rent to commence the first consecutive  
month thereafter until the expiration of said lease as above.  
The lessee hereby agrees to pay the building and its contents a rent, to be determined by the terms of the lease, and the lessor only requires the term of the lease to be paid in full, and the lessor only agrees that the cost is to be considered bound and the lessee not to pay more than the sum of \$400.00 per month for any business other than business carried on in said house if the lessor so desires and gives notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the term then the whole of the unexpired time becomes immediately due and payable.

Outside signs for the business shall not conflict with the general appearance of the building and the part of the building must be committed to the lessor before being erected.

To have and to hold the said premises unto the said lessee, J. H. Pierce,  
executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it gives notice of the same one month prior to the other party. One year. months written notice previous to the time of the desired termination, but the destruction of the premises by fire or lightning, or any casualty or other casualty, or one month's arrear of rent, shall terminate this lease, at the time of such casualty. The lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay, and agrees to make no repairs, improvements or alterations in the premises without the written consent of the lessor unless such work is necessary without the lessor's written consent.

The lessor hereby acknowledges having received a copy of this lease.
