The lessee hereby agrees to take the building just as it stands unless otherwise ready upon his writing, and the lessor only require of the lessee the two of the promises for the business mentioned but no other. The reason he requires the roof should it fail, is it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from him should any occur. One of the greatest lottery business either than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business be discontinued or the premium withdrawn before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Chattels shown to the tenant which may connect with the premises or any other part of the building must be consented to by the lessor before being introduced.

The above and the said premises unto the said lessee, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it shall give to the other party months written notice previous to the time of the desired termination, but the destruction of the premises by fire or sinking it until for occupancy or other casualty, or months notice of rent, shall constitute the lease at an end. The lessee agrees to make good all breakage of glass and all other injuries done to the premises during the term, except such as are caused by natural decay and wear due to the ordinary use, damage or carelessness. In the premises without the written consent of the lessor the lessee may not make any alterations, additions, or removals.
