

LEASE

THE STATE OF SOUTH CAROLINA, }
County of Greenville, }

Whereas the County of Worcester, lessor,
in consideration of the rental hereinabove mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto
~~the said Worcester County~~^{Worcester County, State of Massachusetts}, lessee,
for the following use, viz., for the erection of a dwelling house near Worcester,
at the place and office,

for the term of Five years, and the lessor, to make the sum additional
paid by the lessee at the end of said lease herein before,
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of \$ 600.00

... payable at the date last written of the sum of £100 per annum, the lessee hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only requires of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from water should any occur. Use of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to be affixed shall not extend beyond the parapet or any other outside part of the building, must be consented to by the lessor before being erected.

The above may be said promises unto the said lessor, to be held by the said lessor, until satisfied, to last for one year, and thereafter for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party, six months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or twelve months' notice of rent, shall terminate this lease, at the lessor's desire. The lessee agree to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-let without the lessor's written consent.

The licensee hereby acknowledges having a copy of this lease.
