

LEASE

In consideration of the rental hereinabove mentioned, have granted, bargained and sold, and by these presents do grant, bargain, and sell unto

lesser,

for the following uses, viz.: Building, Land, Buildings and the contents, Buildings and the
contents of House No. 118 in City of City in State of State of State of State
Buildings shall be located at Address Block Lot Block Lot Block Lot Block Lot
for the term of Years beginning on the 1st day of Month, Year and
Ending on the 1st day of Month, Year.

In consideration of the use of said premises for the said term, promises to pay the said holder the sum of One hundred Fifty

payable at the end of the term. The lessor further agrees to let the building to the lessee for the sum of £100 per annum, and the lessee hereby agrees to take the building that he it stands without otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from leakage should any occur. One of the premiums for any business other than herein named for shall cancel this lease if the lessor so desires and give notice of seven months.

If the business is discontinued on the premises mentioned before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outlets signs to be erected shall only connect with the貫道 or any other outside part of the building must be connected to by the lessor before erecting.

To have and to hold the said premises unto the said lessee, ~~for the term of one year~~,
executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the
party desiring to terminate it after the expiration of the term above mentioned, give to the other party three months written notice previous
to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or one hundred
months arrear of rent, shall terminate this lease, at the lessor's discretion. The lessee agree to make good all breakage of glass and all other injuries done to the
premises during the term, except such as are produced by natural causes and agree to make no repairs, improvements or alterations in the premises without the
written consent of the lessor nor sub-lease without the lessor's written consent.
