

LEASE

THE STATE OF SOUTH CAROLINA,
County of Greenville.

Mrs Pauline Lee lessor,
in consideration of the rental hereinafter mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto
Bernell Ayers and M. H. Huggins lessee,

for the following use, viz: retail grocery store, also the side alley back side
of building known as 207 1/2 Broadway St. City of Greenville, S.C. the City of
Greenville, S.C. and the County of Greenville, S.C. and the State of South Carolina.
the lessor hereby agrees to give all other equipment, tools, and fixtures, the
same as the lessor has in the building at the date of the execution of this lease.
It is understood that the lessor has no interest in the building or the
land on which the building stands.

and the said lessee
in consideration of the use of said premises for the said term, promises to pay the said lessor the sum of Twenty (\$20.00)

Dollars
per month payable in advance

The lessor hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only require of the lessor the use of the premises for the business mentioned in the above. The lessee to repair the roof should it leak; it is also fully agreed that the roof is considered sound and the lessee not to pay any damages for water should any come. One of the premises for any business other than herein called for shall curtail this lease if the lessee so desire and give notice of same in writing.

If the business is discontinued on the premises wanted before the expiration of the lease then the whole of the unexpired time hereinafter immediately to be paid.

Outside signs to be erected that may connect with the principal or any other outside part of the building must be consented to by the lessor before being erected.

The Lessee agrees to keep the roof of the building in good
condition at all times.

It is further to be made agreed that in the event the lessee
should be unable to make payments and pay the rents as herein
before provided they may terminate this lease by giving to the
lessor instantly (24) days notice of their intention to terminate the
same.

To Have and to hold the said premises unto the said lessee, his heirs, executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party three months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or three month's absence of rent, shall terminate this lease, if the lessor so desires. The lessee agree to make good all breakage of glass and all other injuries to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-let without the lessor's written consent.
