

LEASE

THE STATE OF SOUTH CAROLINA,
County of Greenville,

Mr. Sarah W. Thachator

In consideration of the rental hereinbefore mentioned, have granted, bargained and released and by these presents do grant, bargain, and lease unto

T. H. Mitchell

for the following use, viz.: Garlic Shop

one story store space located at # 1625 on the East side of Augusta Rd.

For the term of five years beginning June 1, 1946 and ending May 31, 1951

In consideration of the use of said premises for the said term, promises to pay the said lessor the sum of

Forty (\$40.00) Dollars per month

payable monthly in advance

The lessor hereby agrees to take the building just as it stands unless otherwise agreed upon in writing, and the lessee only requires of the lessor the use of the premises for the business mentioned but no other. The lessor to repair the roof should it leak, it is also fully agreed that the roof is considered sound and the lessor not to pay any damages from falls should any occur. One of the premises for any business other than herein called for shall cancel this lease if the lessor so desires and give notice of same in writing.

If the business is discontinued or the premises vacated before the expiration of the lease then the whole of the unexpired time becomes immediately due and payable.

Outside signs to the exterior that may connect with the garage or any other outside part of the building must be removed to by the lessor before being erected.

To have and to hold the said premises under the said lease, R.C., executors and administrators for the said term. It is agreed by the parties hereto that this lease shall continue from year to year on the same terms, unless the party desiring to terminate it after the expiration of the term above mentioned give to the other party 30 days months written notice previous to the time of the desired termination, but the destruction of the premises by fire or making it unfit for occupancy or other casualty, or 30 days months accrued of rent, shall terminate this lease, if the lessor so desires. The lessee agree to make good all breakage of glass and all other injuries done to the premises during the term, except such as are produced by natural decay and agree to make no repairs, improvements or alterations in the premises without the written consent of the lessor nor sub-lease without the lessors written consent.

The lessee hereby acknowledges having a duplicate of this lease.
