James S. Gary, his heirs and assigns, all of my
undivided interest of the following described lots,
all that piece, parcel or lot of land situate, lying
and being in the County of Greenville and State aforesaid
at and five miles from the City of Greenville on the National
Highway leading to Spartanburg said lots being located
on the West side of the said National Highway and
according to survey made by R. E. Dalton, C. E. in August
1893 and being recorded in Plat Book 3, at page 213,
also measured 10 ft 10 1/2 inches for full description
refer to said plat for miller and founder, Florrie S. Miller
and L. H. Gary having been deeded the above lots by the
Bally Corporation and recorded in Book 72 at page 153.

plus all of my undivided interest in Lots numbered
located on Bumcombe Street, said lots being in the names of
Gary, Maylie A. Wolfe, C. R. E. C. Stone and Miller originally
by the aforesaid L. H. Gary & C. S. Miller jointly (4416) interest in
said lots, latter 43 of the 44 interest owned by said Gary and
Miller having been deeded to L. G. Houston, my interest in
said 2 lots now amounting to one third of one fourth interest
in said lots which is fully conveyed by this deed.

Also my interest in all that lot of land situate on the
West side of Bumcombe Road, near the corporate limits of the
City of Greenville, County and State aforesaid, being known
as lot number 44, four on plat made by W. A. Hudson, November
the 1896, and having the following metes and bounds.

Beginning at a point on said Bumcombe Road 61 feet from
west foot Street (Montgomery Street) running between Pinckney and
Bumcombe Streets through the property of M. P. Lambrem, said point
of beginning being the Northeast corner of lot formerly conveyed by
M. P. Lambrem to John Marchbanks, thence with Bumcombe Road north
40 1/2 west 52 feet to a post in the road, thence with line of said road
north 41 1/2 west 10 feet to a stake in corner of lot formerly sold to
Cumberly, thence with Lambrell's line south 65 feet west 98 feet to stakes
thence south 36 feet east 62 feet to a stake, thence north 55 feet to the
beginning corner.

Also, that other lot of land adjoining the above; Beginning at a point
on west side of Bumcombe Road 62 feet from the corner of lot sold to Sam
Cumberly and running thence south 24 75 east 61 feet to the corner of Bumcombe
Road and above mentioned west foot street (Montgomery), thence along said street
south 56 25 west 89 feet to a stake, thence north 34 feet west 61 feet to a
stake, thence north 56 25 east 61 1/2 feet to the beginning corner. Also, that certain
piece or parcel of land deeded to L. H. Gary and H. C. Beattie recorded in Volume
124 at page 203 by Liles & Setfield who are half interest in said property
is hereby conveyed to James S. Gary.
