M. S. Burdett
All of those two certain pieces, parcels and tracts of land situated lying and being in Austin Township, County and State aforesaid, bounded by lands of H. H. Hart and or of S. R. Burdett estate, and tract number 1 of the sub-division the home place of said late M. S. Burdett, and being tracts number 2 and 3 of said sub-division, as is shown in that by survey made by H. J. Riddle, Dec., 1892, of the estate of said M. S. Burdett, and having metes and bounds, as follows;

Tract #2. Beginning at an iron pin near Public Road, corner of tract #1, and running thence S 23.50 N. 87 1/2' to iron pin; thence S. 8. 15 E. 829' to pin, J. S. Hoppers corner (or line); thence N. 52.30 N. 515' to stone; thence N. 18. 15 N. 208' to Holly; thence N. 80 N. 501' to ash; thence N. 41 E. along line of S. R. Burdett estate 445' to stone; thence S 68.45 E 300' to the beginning corner, containing eleven and fifty-six hundredths (11.56) acres, more or less, and being a part

Tract #3. Beginning at an iron pin in center of the Public Road, corner tract #1, and running thence with said road S. 74-10 E. 412' to pin in center of said road; thence N. 18 N. 136' to pin; thence N. 83-20 E. 216' to pin, H. H. Hart's corner; thence with Hart's line N 5.45 E. 425' to pin, corner S. R. Burdett estate; thence with line of said estate S. 83-20 N. 473.5' to pin; thence S. 18 N. 436.5' to the beginning corner, containing five and forty-four hundredths (5.44) acres, more or less, and being a part (metes) of tract of 45 acres conveyed to said M.
