All that piece, parcel or lot of land in Pacis Mt. Township, Greenville County, State of South Carolina;  
Beginning at a stake in the center of road as shown on plat of land of H. P. Mc Gee and C. M. Mc Gee, as Trustees, made by H. P. Mc Gee October 23, 1929, joint corner of tracts nos. 1 and 2; thence a line to the center of said road N. 55 1/2 W. 1.55 chains to a bend in said road; thence N. 19 - 0 W. 2.30 chains to bend in road; thence N. 13 1/2 E. 4.00 chains to a stake in center of said road, also corner of tract no. 4; thence N. 17 - 10 W. 5.60 chains to iron pin in Sango-top Creek; thence following the meanders of said creek, a traverse line as follows: N. 16 1/2 W. 4.35 chains to bend in said creek; thence N. 23 1/2 E. 3.10 chains to bend; thence N. 49.00 E. 2.22 chains to bend; thence N. 35 1/2 E. 3.50 chains to bend; thence N. 45.00 E. 70 links to bend; thence N. 30 1/2 E. 1.10 chains to bend; thence N. 72 - 00 E. 3.20 chains to bend; thence N. 43 - 00 E. 2.70 chains to Sweet Gum (down); thence, crossing of a road on bridge N. 86 1/2 E. 1.39 chains to stake; thence S. 31 1/2 E. 16.30 chains to stake, corner of tract no. 2; thence S. 51 1/2 W. 18.27 chains to the beginning corner, containing 29.4 acres, more or less.

This conveyance is made under the Trust created by B. M. Mc Gee which is recorded in P. M. C. Office for Greenville County in Book 100, Page 493, and under authority of the Decree of the Court of Common Pleas in the case of H. P. Mc Gee vs. Ida May Bull, et al. Constituting Judgment Roll E. 3166 on file in the office of the Clerk of Court of Greenville County, and being the same lot of land conveyed to us by H. P. Mc Gee and C. M.
