All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, just outside the corporate limits of the City of Greenville, on the South side of Camille Avenue, and being designated as lot No. 4 on plat of the property of T. Q. Donaldson Estate, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book H, at page 164, and having according to said plat the following metes and bounds, courses and distances, to-wit:
