

Lots Nos. 3, 4, and 5 of the G. W. Gowan property in the Town of Inman, said County and State, as shown on the Adkins plat. Said lots together fronting 69 feet on Mill Street and running back 85 feet to a fifteen-foot alley. See Deed Book 6-6, page 365.
