all that certain lot or parcel of land, situate in Greenville Township, Greenville County, State of South Carolina, beginning at a stake in the center of a public road and being the corner for the Tarrant Land, thence on the line of the Tarrant Land North 59 1/2 degrees East 3.35 Chains to a point in the center of the Southern Railroad right of way, thence as the center of said Railroad right of way South 33 1/4 degrees East 30.34 Chains to another point on the center of said Railroad right of way, thence South 39 1/4 degrees East 5.37 Chains to a stake in the center of the public road; thence as the center of said public road in a northeasterly direction 31.48 Chains to the point of beginning, and containing fourteen and four fifties (14 4/5) acres, to be the same of more or less.
