To all whom these presents may concern:

I, C. R. Bramlett, Sheriff of the County and State aforesaid send greeting:

Whereas, by virtue of an execution issued out of the Court of Common Pleas of and for the County and State aforesaid, under date of August 5th, 1932, and returnable according to law, directed to me as Sheriff of said County and State, and lodged in my office, commanding me out of the personal and real property of William Jackson to satisfy a certain judgment which was rendered on the 18th day of October, 1931, in an action of Ollie McCallough against William Jackson, in favor of said plaintiff against said defendant for the sum of Eighty (\$80.00) Dollars, as appears in Judgment Roll E-3501, filed in the office of the Clerk of Court of Common Pleas for said County and State, I have levied upon two certain lots in the said County and State, more particularly described as follows:

All those two (2) lots adjoining each other on or near Calhoun Street, City of Greenville, as shown on Plat made for the Greenville Trust Co., Plat Book C-13; Beginning at a point on the SE side of Calhoun Street, Joint corner of lots B and C, and running thence S. 77-48 E. 200 feet, more or less, to a point on a 10 ft. alley; thence along said alley S. 16-15 W. 35.9 feet to a point at corner of lots I and J; thence N. 77-45 W. 200 feet, more or less, to a point on Calhoun Street; thence along said street N. 16-15 E. 35.9 feet to the beginning corner, adjoining lots B, D, H, and J, and being lots C and I on said plat, and being the same lots as conveyed by C. C. Good to William Jackson by deed recorded in Deed Book 83, at page 42, Office of the R. M. C. County and State aforesaid, reference to which plat and deed is hereby made for a full description.

And, whereas, after due and legal notice to the said Sheriff of the said County and State, did on the 5th day of Sept. 1932, the same being the first Monday in said month, between the hours of eleven in the forenoon and three in the afternoon of that day, at the Courthouse in said County and State, openly, publicly and fairly, and according to the usage and customs of vendors, sell for the towards satisfaction of said judgment and execution, unto Lucinda Williams for the sum of One Hundred (\$100.00) Dollars, being at that price the highest and last bidder for the same.

Now, know ye, that I, C. R. Bramlett, Sheriff as aforesaid, by virtue of the said execution, levy and sale, and of the statute in such cases made and provided, and for and in consideration of the sum of One Hundred (\$100.00) Dollars to me in hand paid, did sell and by these presents do grant, bargain, sell and convey to the said Lucinda Williams, her heirs and assigns forever, all those two certain lots situate lying and being in the County and State aforesaid, described hereinabove.

Together with all and singular, the members and appurtenances thereunto belonging, and all estate, title and interest which the said William Jackson of right had in and to the same; To have and to hold the said premises, with the appurtenances, unto the said Lucinda Williams, her heirs and assigns forever.
