Contract of Sale and Purchase.

Tolbert, hereinafter called the Purchaser, Witnesseth: That in consideration of the agreements and payments hereinafter named, the Seller agrees to sell and the Purchaser agrees to buy, the hereinafter described lot of land at the price of This is an exchange of property \$ 8 0 0 0 Dollars. (\$ \_\_\_\_\_), of which \$5.00 has been paid in cash and the balance is payable as follows:

Arnold transferring 309 3/10 acres, more or less of land in Oaklawn Township, Greenville Co. on road leading from the Way Place on Augusta Road to Pelzer, S. C. & known as the Burnett Place & Johns lands of Hugh Madden, Jim Rice & others. There is a mortgage now on this for \$3000.00 in favor 1st Carolinas Joint Stock Land Bank which Tolbert assumes & pays to Arnold \$700.00 in cash Tolbert to have rent from farm for year of 1933.

until the purchase price is paid in full with interest on the unpaid portion from date at the rate \_\_\_\_\_ per cent. per annum to be computed and paid \_\_\_\_\_ and if unpaid to bear interest at same rate as principal and in case said sum or any part thereof be collected by an attorney or through legal proceedings of any kind, the Purchaser agrees to pay 10 per cent. in addition to the amount as attorney's fee.

The seller agrees that there shall be made to the Purchaser a good warranty deed for said property.

It is agreed that all commissions are due and payable to the Wm. E. Raser Real Estate Company upon the signing of this contract.
