situate on Reedy Fork Creek and having the following meters and bounds, as shown by plats of survey made by John M. Curston, Surveyor, on the 17th day of April 1908, to wit:

Tract no. 1. Containing 77 acres, more or less. Beginning on a stone 340 M on bank of Reedy Fork Creek and running thence N. 78 3/4 E. 220 to a c., thence S. 47 1/2 E. 92 links to P.O. stubby; thence S. 82 1/2 E. 60 to stone; thence S. 52 E. 3.65 to stone; thence S. 55 1/4 N. 17.50 to stone 0 M; thence S. 31 1/2 E. 8.22 to stone 0 M; thence S. 66 3/4 E. 16.60 to stone 34; thence N. 31 3/4 E. 42.40 to stone 34 M; thence N. 65 1/2 N. 21.35 to stone 34 M; thence S. 31 1/2 N. 7.60 to stone 340 M; thence S. 1 1/2 E. 6.80 to stone 340 M, to the beginning corner. Also, all that tract, piece, or parcel of land lying being and situate in Greenville County and State aforesaid in Keose Township on waters of Reedy Fork Creek and has the following marks, bearings and distances: Beginning on a stone 34 M near water edge of Reedy Fork Creek; thence S. 1 1/2 N. 5.25 to a pine 340 M; thence S. 60 1/2 N. 14.69 to a stone 340 M; thence S. 1 1/2 N. 4.50 to a stone 34 M; thence N. 54 3/4 E. 19.50 to a stone 34 M; thence N. 2 1/2 N. 6.70 to a white oak 34 M; thence S. 78 3/4 N. 220 to the beginning corner and contains one acre, more or less and adjoins lands of J. M. Griffin and W. M. Lenderman. See deed recorded in Vol. 111 at page 130.

Also, all that piece, parcel and tract of land lying being and situate in Keose Township, County and State aforesaid, lying near waters of Reedy Fork Creek and has the following meters and bounds, marks and bearings and distances: Beginning at a white oak being a corner of a tract of land recently purchased from W. M. Lenderman by J. M. Griffin and running south of East 82 feet to a post oak; thence West of South 172 feet to a stone on the beginning line; thence following the old line 209 feet to the beginning corner and contains one tenth (1/10) of an acre, more or less, and adjoins lands of J. M. Griffin and W. M. Lenderman. See deed recorded in Vol. 111 at page 682.
