All that certain piece, parcel or tract of land situated, lying and being in Saluda Township, Greenville County, State of South Carolina, having the following metes and bounds to wit:

Beginning at a point in the bridge over the center of the creek where the Old Buncombe Road crosses said creek and runs up the right fork of said creek a total of 26.70 chs to the corner of land conveyed by W. D. McBrayer to Barney Young, thence with this line N. 9 E. 1.79 chs to a S. trunk sweet-gum in old road, thence with said old road, N. 46-¹⁵₄₅ E. 2.57 to bend in said road, thence N. 48 E. 3.10 to bend, thence N. 45-¹⁵₄₅ E. 2.01 to bend in said road, thence N. 53 E. 2.50 to bend in said road, thence N. 3¹⁵ E. 3.18 to branch; thence up said branch as a line 1.50 chs to a sweet-gum at the head of branch, thence N. 36-³⁰₄₅ E. 5.00 to a Red oak, thence S. 43-⁴⁵ W. 2.92 chs to a stone, thence N. 82 W. 6.00 to a P. O., thence N. 46-¹⁵ W. 9.57 to a dogwood, thence N. 67 W. 4.00 chs to Chestnut; thence S. 47-¹⁵ W. 1.00 ch. to a corner, thence S. 12-¹⁵ E. 14.75 chs to a corner, thence S. 77-⁴⁵ W. 7.70 chs to a corner on the Buncombe Road, thence with the new Buncombe Road as a line N. 12-¹⁵ W. 8.47 chs to a bend in said road; thence N. 8-³⁰ W. 1.00 ch to a bend in said road, thence N. 54-¹⁵ W. 1.00 to a bend in said road, thence N. 1-⁴⁵ W. 1.00 to a bend in said road; thence S. 77 W. 1.00 ch to a stone in Spriggs Creek; thence up said Spriggs Creek as the line 4.57 to a stake in creek, thence S. 69-⁴⁵ W. 0.82 ch to a locust post, thence S. 4-¹⁵ W. 14.70 chs to a stone, thence S. 74-¹⁵ W. 3.10 to a stake in said line on the Old Buncombe Road, thence down the Old Buncombe Road 19.20 to the beginning corner, containing 62.10 acres, more or less.
