assigns, forever;

All that certain piece, parcel or lot of land
situate, lying and being in Greenville Township,
Greenville County, and in the State of South
Carolina, known and designated as Lot No. 11
by Surveyor Rights on plat recorded in Plat
Book B, page 35, and having the following
metes and bounds:

Beginning at an iron pin on King Street
at the intersection of King Street and Jamison
thence along King Street S. 36° 6' 18" feet to iron
pin at corner of Lot 12, page 35, 24' 0" 100 feet to an
iron pin in line of property of American Bank &
Trust Co.; thence along line of said property N.
1° 36' 11" 20' 8" feet to iron pin on Jamison Street,
thence along Jamison Street N. 53° 40' 21. 31. 2 feet
to iron pin; thence S. 88° 24' 21. 124. 4 feet to the
beginning corner. Being the same lot of land
conveyed to me by Alice D. Oynell, deed dated
August 25, 1932, recorded O. M. C. Office, Volume

along Jamison Street N. 53° 40' 21. 112 feet to the
