All that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, on the waters of Poinsett Branch, and having according to a recent survey thereof made by C. M. Furman, Engineer, September 2, 1933, the following mates and bounds, courses and distances, to-wit:-
