D. Earris's Farm -on the read to Willimon's Gin. Land agreed on by Mr. Harris and Mr. Taylor.

Together with all the rights of ingress and egress over any and all lands of the said lessee to the above described leased and rented land. The said J. D. Harris agrees to rent the lesse four miles including gears at the rate of \$1.00 per day por mule for all the days switchle for work, up to August 1st, 1934.

To have and to hold unto the said South Carolina emergency Relief Administration from the date before and through the thirty-first day of December, 1934. With the privilege of the said South Carolina Amergency Relief Administration to exercise as they deam fit, the continuance of this lease for . . . eriod of one year after the thirty-first day of December, 1934, for the same consideration recited above. The South Carolina amergency Relief Administration to have the right and privilege to ente upon such lands of the said lessor for the purposes of removing from the above described rented land any and all improvements that the said South Carolina amergancy Relief Administration may erect upon said lands. The said South Carolina amergency Roll of Administration to have such right for a period of six menths after the termination of this lease or renewal there or .
