"All that piece, parcel or lot of land in Greenville County, State of South Carolina, and in the City of Greenville, fronting on the south side of Randall street, and being known and designated as lot "B", as shown on plat of the property of H. J. Martin recorded in the R. M. C. Office for Greenville County in Plat Book G, page 255, and having according to said plat the following notes and bounds, to-wit:

"Beginning at an iron pin on the south side of Randall Street, joint corner of Lots C and B, and running thence with Randall Street N. 85-00 W. 50 feet to an iron pin, corner Lots A and B; thence along joint line of said lots S. 2-20 W. 149 feet to an iron pin; thence S. 84-55 E. 50 feet to an iron pin, joint rear corner of Lots B and E; thence with the rear lines of Lots E, D, and C.
