the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Ethel Willis and Allene Willis, their heirs and assigns:

All that piece, parcel, lot of land in the County of Greenville, City of Greenville, on the north side of Watts Avenue, being known and designated as lot No. 22 of the property of Parish, Gower and Martin according to plat recorded in the R. M. C. Office for Greenville County, Plat Book G, at Page 197, and having the following notes and bounds, to-wit:

Beginning at an iron pin on the north side of Watts Avenue, joint corner of lots Nos. 22 and 23 and running thence with joint line of said lot N. 0-48 E. 176 feet to iron pin, joint corner of lots 22 and 23, thence N. 88-58 W. 52 feet to an iron pin on line of lot No. 19; thence along the rear lines of lots Nos. 19, 20 and 21, S. 0-48 W. 176 to an iron pin in the north line of Watts Avenue, thence along line of Watts Avenue S. 88-58 E. 52 feet to the point of beginning.

Grantee accepting this deed herein assumes and promises to pay the 1933 City, State and County taxes.

The above-described land is the same conveyed to me by Leila M. Hilley, on the 27th day of Oct., 1930, deed recorded in office of Register of Deeds Conveyances for Greenville County, in Book 133, Page 623.
