Noland Meyers, Commissioner, his heirs and assigns.

All that certain lot of land situate, lying and being near the corporate limits of the City of Greenville, in the State and County aforesaid, on the West side of Underwood Avenue, or Street:

Beginning, at a point on the West side of Underwood Avenue, corner of lots 44 and 45, 122.8 feet from the Northwest corner of Monticello and Underwood Avenues; thence along line of lot No. 44, N. 74-12 W. 150 feet to the joint corner of lots 45, 46, 70 and 71; thence along line of lot No. 70, N. 15-48 E. 50 feet to joint corner of lots 45, 46, 69 and 70; thence along line of lot No. 46, S. 74-12 E. 150 feet to Underwood Avenue; thence along the West side of Underwood Avenue S. 15-48 W. 50 feet to the beginning corner.


