All that certain piece, parcel or tract of land situate, lying and being in the State and County aforesaid in Little Township, on Branch water of Rocky River, and having the following metes and bounds, to-wit:

Beginning at a pin on or near the road that leads to grantor's house, and south corner of C. B. Henderson and Gatter, and running thence N. 75-30 W. 243 feet to pin; thence N. 61-20 W. 652 feet to pin; thence N. 61-50 W. 842.5 feet to iron pin; part corner of Conger and Lower; thence N. 69-50 E. 213.5 feet to iron pin; thence along the line of Sam & John Henderson, and G. Ouyed N. 69-20 E. 1447.7 feet to iron pipe; thence S. 20-0 E. 1366.6 feet to iron pin in road; thence S. 69-55 W. 556.7 feet to beginning corner, containing 33.33% acres.
