All that piece parcel or lot of land, the building and improvements thereon situate, lying and being in the City of Greenville, County and State aforesaid, and having the following metes and bounds to-wit:

Commencing at the west corner of a brick wall on the north side of West Washington Street, corner of property recently conveyed from the grantor herein to A. McLee, and 56 feet west of the corner of lot #3, as shown on plat of property of McCrorey, Bates and Williams, recorded in the R. M. C. Office for Greenville County in Plat Book 6, at page 249, thence along the west edge of said wall N. 41-40 E. 15 feet to an iron pin on the south side of a ten foot alley, thence along the south side of said ten foot alley S 48-40 E. 23.6 feet to another pin, joint line of lots #2 and 3, of the plat above referred to; thence along joint line of lots 2 and 3 S. 41-40 W. 15 feet to a point on the north side of West Washington Street; thence along the north side of West Washington Street N. 48-50 W. 23.6 feet to the point of beginning; this being all of lots #3 and a portion of lot #2 as shown on the plat above referred to above, and being a portion of the same lots of land conveyed to the grantor herein by J.
