A certain tract of land containing 36 acres he same
more or less and known as part of the Leo Williams
place and also known as the home place of J.
Rhoades in Greenville County, Duncan Township,
State aforesaid, and deeded to Sallie Rhoades by
Jannie Collier, Emma Gessett, Anna Collier, described
as follows, an old Lawrence Road on Cooley Bridge
Road and bounded by lands on North Big Linn
Creek and east by P. C. Gessett South A. J. Williams
place and Emma Gessett and the Mulligan place and
west by Robert Yancey Rhoades that now decided this
day to him alias by Anna Collier. The said Leo Rhoades
shall pay unequal part with my other children in all
debt that I may die leaving unpaid. Also to pay
an equal part in Sallie Rhoades debts, burial
expenses John Rubin Rhoades, Jannie Robert & Emma
Moore, Martha Chambers. Also receives the right to rent and collect rents for
said land as long as she lives.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said *Leo Rhoades*, his heirs and assigns, forever.

AND I do hereby bind *myself*, my heirs, executors and administrators to
warrant and forever defend all and singular the said premises unto the said *Leo Rhoades*, his heirs and assigns, against all persons whomsoever lawfully claiming, or to claim the same, or any part thereof.
