Margaret Cooper Hammond, my daughter in law, all that piece, parcel or lot of land in Greenville Township, County and State aforesaid, on the East side of Church Street and being known and designated as lot no 8 in Block C of the O. P. Mills property as shown on a plat recorded in the R. M. Office for Greenville County at page 284, and having according to said plat the following metes and bounds, to wit: Beginning at a iron pin on Church Street point corner of lots no 8 and 9, and running thence with the joint line of said lots N. 53-18 E. 200 feet to an iron pin thence N. 36-50 W. 55 feet to another pin corner of lot no 7, thence with line of that lot S 53-18 E. 200 feet to an iron pin on Church Street thence with said Church Street S 36-50 E. 95 feet to the point of beginning.
