All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being at a corner 84.75 feet from Southeast corner of Anderson and St. John Streets, and running thence along said Anderson Street 84.75 feet to iron pin; thence S. 79 E. 165.75 feet; thence N. 13 S. 84.9 feet to lot formerly owned by Agnew; thence with said lot N. 79 E. 168 feet to beginning corner.

As a part of the consideration of this deed of conveyance the Grantee herein by accepting this deed does hereby agree to pay State and County tax for the year 1834 and the year 1835 which are levied against the property herein described.

The above described land is the same conveyed to me by John Fischer, on the day of 10, 1835, deed recorded in office of Register of Deeds for Greenville County, in Book 1, Page 12.

TO HAVE AND TO HOLD, all and singular, the rights, numbers, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining, heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said S. J. Fischer, his heirs and assigns, against me and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.
