Beginning at an iron pin on James Street and running thence North 55 feet to an iron pin, corner of Rushton lot, thence with the line of that lot in a Westerly direction 193 feet to an iron pin on South Main Street; thence with South Main Street 55 feet to an iron pin on James Street; thence along James Street in an Easterly direction 188 feet to the beginning corner.
