in the State aforesaid,

in consideration of the sum of Sixteen Hundred and Sixty (1670.00) Dollars and the assumption of the mortgage hereinbelow set forth

to us paid by Anna M. Bull

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Anna M. Bull all the <sup>1</sup> year parcel or lot of land

in Greenville Township, Greenville County, State of South Carolina, and being on the corner of Stone Ave. and Wilton Street, in the City of Greenville, and being known and designated as lot no 1, as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book "A" at page 84, and having the following metes and bounds to wit: Beginning at the corner of Stone Ave. and Wilton St. and running thence S. 5<sup>o</sup> 5' W. 155 feet to corner, thence N. 87<sup>o</sup> 37' feet to corner of lot formerly owned by A. J. Munn; thence along line of said lot N. 5<sup>o</sup> 5' E. 158 feet to Stone Ave.; thence along Stone Ave. S. 84<sup>o</sup> 6' E. 61 feet to the beginning corner, being the same lot of land conveyed to Henry Campbell by A. M. Payne and Mary A. Holliday by deed recorded in the R. M. C. Office for Greenville County in Deed Book 151 at page 129, dated June 4, 1917.
