of Greenville of the public streets hereinafter mentioned.

In the State aforesaid, the receipt whereof is hereby acknowledged, have passed between, and by these presents do grant, bargain, sell and release, unto the said City of Greenville all those certain parcels of land or streets situate lying and being in the City of Greenville, State of South Carolina, described as follows:—Central Avenue and Barrett Street as shown on plat of the property of Marshall Estates prepared by Dalton & Nease, Engineers, May, 1932, and recorded in the R. M. C. Office for Greenville County in Plat Book "H" at Page 254 and 255, and being more particularly described, according to said plat as follows:

Beginning at an iron pin which pin is at the eastern intersection of Marshall and Central Avenue, corner of Lot No. 32 and running thence with the southern side of Central Avenue N. 48-06 E. 253.4 feet to a point in line of Lot No. 28, thence N. 59-06 E. 44 feet to a point in line of said lot, thence N. 81-31 E. 44 feet to a point in line of said lot, thence S. 76-17 E. 44.1 feet to corner of Lot No. 27, thence S. 65-22 E. 125 feet to western intersection of Barrett Street and Central Avenue, thence along the west side of Barrett Street S. 28-05 W. 297.2 feet to northern side of Marshall Avenue corner of Lot No. 22, thence along northern line of Marshall Avenue S. 66-12 E. 45.1 feet to an iron pin in the eastern line of Barrett Street, corner of Lot No. 21, thence along the eastern side of Barrett Street N. 28-05 E. 296.5 feet to an iron pin in the southern side of Central Avenue corner of Lot No. 16, thence along the southern side of Central Avenue S. 65-22 E. 135 feet to an iron pin, rear corner of Lot No. 16, thence N. 28-05 E. 37.1 feet to an iron pin in the northern side of Central Avenue Southeastern corner of Lot No. 15, thence along the northern side of Central Avenue N. 65-22 W. 307.4 feet to an iron pin in line of Lot No. 9, thence N. 73-39 W. 47.6 feet to iron pin joint corner of Lots Nos. 8 and 9, thence S. 88-59 N. 52 feet to joint corner of Lots Nos. 7 and 8, thence S. 70-55 N. 51 feet to joint corner of Lots Nos. 6 and 7, thence S. 55-05 N. 40.1 feet to point in line of Lot No. 6, thence S. 48-06 W. 261.2 feet to northern side of Marshall Avenue, corner of Lot No. 1, thence along the northern side of Marshall Avenue S. 66-12 E. 49.4 feet to the point of beginning.
