C., from four hundred to six hundred yards below the fifteen mile post on said road in said State and County, beginning on a stake on Westmoreland's line 745 chains on said line. To a Hickory 37 thence on Nathan Davis line to a post-oak bush 745 chains, thence to the beginning corner, the whole to contain two acres of land, the land on which the above two acres is bounded belonged to the parties named above in the year 1847. The Hickory corner named above is a corner of Dr. M. A. Hunter.
