

(The name Nathaniel meant for Samuel)

Whereas, the parties signatory hereto being lawfully married and have since marriage lived together as man and wife, to which union have been born three children, but the signatory parties hereto have found life incompatible with each other, and unable to agree on matters pertaining to happiness and comfort, and have decided to separate from each other by agreement, upon the following conditions, to-wit:

That the said parties hereto have agreed to and do now hereby bind themselves respectively to separate from, live apart from and dwell in different places from each other; that neither one is to molest or interfere with the social, domestic, economic or other phase of life of the other, nor permit such interference or molestation of the other by any parties related to or connected in business or home life with the other; that each party hereto is to be free to go where each pleases, act and do as each pleases without responsibility to or molestation by the other, and each hereby covenants that each will not permit any interruption of the freedom of the other by any relative or friend of each nor suffer any conditions to exist, where such are within each one's control, that will in any wise molest with nor ten to molest with the absolute freedom and liberty of the other.

That Nathaniel Thomas Hill, the husband, agrees to and does hereby bind himself to pay unto the wife and mother, Dessie Mae Adams Hill, the sum of five dollars per week, or payments averaging that amount, to and for the use, benefit, support and maintenance of the three children of the said parties; and the said Dessie M. A. Hill is hereby granted the custody and control of the said children, but with the absolute right and privilege of the said Nathaniel Thomas Hill to visit the said children as often and where convenient as desired by him, without molestation or hindrance from the said Dessie M. A. Hill or any other persons, and under conditions, under the control of the said Dessie M. A. Hill, such visits to be made at the pleasure and convenience of the said Nathaniel Thomas Hill, but not so as to molest the home life of the said Dessie Mae A. Hill. In case of an agreement at any time as to such visits as to time, place or otherwise, then the said children are to be placed by the said Dessie Mae Hill at some convenient place for a reasonable length of time to permit of such visits by the said Nathaniel Thomas Hill without molestation or interference.

The said Dessie Mae Adams Hill does agree to and hereby releases the said Nathaniel Thomas Hill of and from any and all responsibility for and on account of support and maintenance to herself, so long as the said five dollar per week payments are made, and further does hereby release and forever relinquish any interest or estate of or in and to any property that the said Nathaniel Thomas Hill may now or hereafter acquire; and agrees to, where and when necessary, proper or desired, attend at such time and place as may be agreeable to execute upon her part any instruments by way of dower or otherwise in furtherance of this agreement.

It is distinctly understood that during any sickness or unemployment of the said Nathaniel Thomas Hill, the weekly payments herein provided will not be required, but upon cessation of such sickness or illness, he is to make up for such suspended payments as far as may be reasonably within his power so to do.

It is further understood that in case of any molestation or interference by either with the other any time hereafter, this agreement then is to be at once terminated and ended and of no effect, and each party then and there left to pursue his or her own course as each of their rights may then exist and as each may then be advised.

Any change of, subtraction from or addition to this agreement to be made in writing in duplicate and attached hereto.

This agreement to continue of full force and effect until ended or changed by any subsequent written agreement of the parties hereto.
