East by Rockland Creek in the city and county of Greenville, South
Carolina and being more particularly described as follows:

Beginsing at a point on said Street 100 feet South of the Northwest corner of the property of Mr. M. H. Lance and runs at right angles to said North Street back to the north branch of said Rockland Creek; thence down said creek 60 feet; thence in a line parallel with the street above stated line to a point on Smith Street 60 feet from the beginning point; thence along said Street in a Northern direction 60 feet to the beginning point.
