Whereas W.B. Farr, late of the County and State aforesaid, entered into a contract with Wade Floyd on the day of January, 1922, which is recorded in the R.M.C. Office of the Greenville County in Deed Book 60, page 465, by which the said W.B. Farr agreed to sell, and Wade Floyd agreed to purchase a tract of land containing 25.45 acres, and,

Whereas the said contract was never carried out, but no cancellation thereof was entered of record, and,

Whereas said W.B. Farr died in the year 1922, leaving of force his Will which is on file in the office of the Judge of Probate for Greenville County in Apt. 176, file 11, by which the beneficial interest in said property passed to Clifton Farr, Horace Farr, Herbert Farr and Annie Farr, and,

Whereas said Clifton Farr died intestate on July 15, 1929 as appears by Apt. 247, file 3 in the office of the Probate Judge, leaving all his heirs at law Malicea Farr, his mother, and J.T. Farr, Jr. W.M. Farr, Herbert Farr and H.M. Farr, his brothers, and Annie Farr his sister, and,

Whereas Malicea Farr died in 1931 leaving a Will which is on file in Apt. 280, file 29, by which she left her interest in all real estate to her sons Thomas Farr and Henry Farr.

Now therefore it is agreed between J.T. Farr, Jr., Henry Farr, W.M. Farr, Annie Farr and Herbert Farr, executors in interest of W.B. Farr, and Wade Floyd that said contract above mentioned be and the same is hereby cancelled and declared null and void.
