Whereas Pursuant to Order of the Court in the case of Ruby Head, et al vs. Hattie Emily Harrison, et al dated April 16, 1928, the said Decree appearing a part of Judgment Roll E-962, Office of Clerk of Court of Common Pleas, wherein it was provided in the said Decree, amongst other things that E. Inman, as Master, convey to Mrs Ruby Head by fee simple title "One of the Harrison lots on East Washington Road, in the City of Greenville, South Carolina, to be selected by her; and the said Ruby Head having thereafter selected lot No. 55 as shown by plat book A, at Page 383, and the Master thereafter executed and delivered to the said Ruby Head a deed thereto, in the usual form, dated April 17, 1928, and which said deed was lost, misplaced, or destroyed before recording the same; and

Whereas, Ruby Head, et al on or about the 18th day of February in the year of our Lord nineteen hundred and twenty-eight exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Hattie Emily Harrison, et al., demanding relief as to the real estate described in the complaint, and the cause being at issue, came on to be heard on the 16th day of April, 1928, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman, Master in and for the County aforesaid to Mrs Ruby Head for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear. All that certain tract and parcel of land located in the County and State aforesaid, in the City of Greenville, on the south side of East Washington Road, and designated as lots Nos. 55 and 55 1/2 on a plat of the same recorded in Plat Book A, at page 383, to which reference is hereby craved for a full and complete description of the same, as well as the Decrees of the Court of Common Pleas above mentioned said lots together having a frontage of seventy-five feet on the south east side of East Washington Road by a depth of approximately one hundred and eighty feet, together with all and singular the Right, Members, (Over)
