Garrison, deceased, all transfers being of record in the office of the R. M. C. for Greenville County and having the following metes and bounds to wit:

Lot #1, Beginning at an iron pin on W. P. Mears line running along aforementioned road S. 12 1/2 W. 4.35 chains to iron pin; thence S. 74 E. 4.60 chains to iron pin; thence S. 74 E. 4.60 chains to iron pin; thence N. 12 1/2 E. 4.35 chains to iron pin; thence N. 74 E. 4.60 chains to the beginning corner, containing two (2) acres, more or less.

Lot #2; Beginning at iron pin on road running S. 19 W. 2.60 chains to iron pin; thence S. 74 E. 6.51 chains to iron pin thence N. 34 E. 2.63 chains to iron pin; thence N. 74 W. 7.20 chains to the beginning corner, containing one and three-fourths (1 3/4) acres, more or less.

Lot #3, Beginning at an iron pin on road running along road S. 19 W. 2.50 chains to iron pin; thence S. 74 E. 6.51 chains to iron pin; thence N. 34 E. 2.63 chains to an iron pin; thence N. 74 W. 6.51 chains to the beginning corner containing one and fifty-three one-hundredths (1 53-100) acres, more or less.
