All that certain lot of land situate at the southwest corner of Birnie and Hardlaw Streets, in the City of Greenville County and State aforesaid, known as Lot Number One (1) on the plat of Ladson A. Mills property made by Dalton & Neves dated May, 1930, and recorded in Plat Book 6, page 272, P. M. C. office for Greenville County, and being more particularly described as follows: Beginning at an iron pin on the west side of Hardlaw Street, which pin is 39.3 ft from the intersection of Birnie Street, and running thence S. 72° 16' 24" 81.3 ft. with line of Lot No. 2 to an iron pin in the eastern line of Lot No. 13, thence N. 17° 56' 24" with the eastern line of Lot No. 13 4.91 ft. to Birnie Street, thence with Birnie Street N. 79° 12' to 81.4 ft to the intersection of Hardlaw Street, thence with the western line of Hardlaw Street S. 17° 56' 0" 39.2 ft. to the point of beginning the said lot being one of the lots conveyed to the grantor herein by Ladson A.
