Claude S. Sutton, his heirs and assigns  
The following tracts of land in Greenville County, South Carolina  
all that piece, parcel, or lot of land in \_\_\_\_\_ Township, Greenville County, State of South Carolina.

#1. A certain tract of land lying on both sides of Oil Camp Creek, Beginning on a Hickory Tree on south side of Oil Camp Creek, thence N. 50 W. 500 to a Persimmon, thence N. 11 1/2 W. 1300 to a rock, thence S. 84 W. 250 to a stake, thence N. 42 W. 2150 to a Black Gum in gap of ridge, thence S. 87 1/2 to a pine thence S. 14 E. 400 to a pine, thence S. 42 1/2 E. to a holly, thence S. 59 E. 450 to a rock at ford of Branch, thence S. 6 E. 1350 to a white oak south side of Oil Camp Creek, thence S. 3 W. 4700 to a Chestnut Oak near the top of ridge on Green Mountain, thence N. 44 E. 2600 to a Spanish oak, thence N. 6 W. 2875 to a holly the beginning. Containing 105 acres more or less. Being same tract of land conveyed to John Hart by Levi Hart and Lula Hart. Also a certain tract of land adjoining the above mentioned tract lying on the waters of Oil Camp Creek, Beginning on a Hickory Tree on south side of Oil Camp Creek near old trail, Running N. 50 W. 500 to a persimmon by ditch, thence N. 11 1/2 W. 810 to a stake, thence N. 75 E. 1122 to an Apple Tree, thence S. 23 E. 1100 to a stake on south bank of Oil Camp Creek, thence to the beginning. Containing two acres more or less. Being same tract of land conveyed to John Hart by William Jones.

#2. A tract or parcel of land situated in the State and County aforesaid containing four hundred acres (400) more or less, more particularly described in a deed from M. L. Hart to Matilda Hart, dated January 26, 1888, recorded in Deed Book 24 page 723, R. M. C. Office, said County as follows: Beginning on a Hickory on south side of Oil Camp Creek (a corner of Jones land) and run thence S. 6 E. 28.75 to a Spanish oak corner of Jones land, thence S. 44 W. 29.50 to a Chestnut 3X, then N. 50 W. 27 to a Pine 3X, thence S. 37 1/2 W. 40.00 to a Hickory 3X, thence N. 33 3/4 W. to Oil Camp Creek, thence with said creek to said creek to a stake on Wm Jones line N. 40 W. of beginning thence S. 50 E. to the beginning. Bounded by land of Wm McTearney and others.

#3. A tract or parcel of land lying and being situated in the State and County aforesaid, containing six hundred acres (600) more or less, more particularly described in a deed from M. L. Hart to Matilda Hart, dated January 26, 1888, recorded in Deed Book 24 page 125, R. M. C. Office, said County, as follows: on north side of Oil Camp Creek, waters of Middle Saluda River. Beginning on a persimmon north of Oil Camp Creek, a corner of Wm Jones land, run thence N. 11 1/2 W. 13 chains to a stake 3X, thence S. 84 W. 5.50 chains to a stake 3X, thence N. 45 W. 61 chains to a Chestnut on top of pinnacle of Cowpens Ridge, thence S. 74 W. 4 chains to a Chestnut Oak 3X, thence S. 84 W. 9.50 chains to a stake 3X then S. 76 1/2 W. 9.80 chains to a Chestnut oak 3X, thence S. 83 1/2 W. 7.90 chains to a Chestnut Oak 3X, thence N. 77 W. 5.70 chains to a Chestnut oak 3X, thence N. 85 W. 11.50 chains to a Forked Pine 3X, thence S. 74 3/4 W. 12.40 chains to a Chestnut oak 3X, thence S. 71 1/2 W. 11 chains to a Spanish oak 3X, thence S. 60 W. 15.25 chains to a Chestnut 3X, thence S. 37 1/2 E. to Oil Camp Creek, thence down said creek to a stake on land of said creek, S. 50 E. 4 chains to the beginning containing 600 acres more or less, adjoining lands of Wm Jones, J. W. Gray and others.
