H. W. Jordan, his heirs and assigns.

All that certain lot or tract of land in the County of Greenville, State of South Carolina, namely, said tract of land located south of Greenville on the east side of the National Highway and b & g Railroad and being a portion of lot no 6 according to plat of property of L. C. Good made by H. M. East, Engineer, recorded in R. M.C. Office of Greenville County, said portion herein conveyed having a frontage on the paved highway of 100 feet and a depth of 315 feet, and containing one acre more or less, and being the southwestern corner of said lot no 6.

REQUITED withal and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
