 All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 3, Block 6, of Kamatenahs on the North side of Oregon Street, having the following metes and bounds:  
 Beginning at a stake on the North side of Oregon Street and running thence along Oregon Street N. 63° 13' 06" 60 feet to a stake; thence N. 26° 30' W. 165 feet to a stake; thence S. 63° 30' W. 60 feet to a stake; thence S. 26° 30' E. 165 feet to the beginning corner on Oregon Street.
